1. Exterior Alterations or Repairs

Describe clearly and in detail all work to be done and reason for work. *Cite specific Historic Standards which you feel are applicable. Attach additional sheets if needed.*

Include any or all of the following which are applicable:

Sketches, drawings, photographs, specifications, material cut sheets, color charts or other descriptions of proposed changes to the building façade or roof, new additions or site improvements including landscaping, lighting, etc. (Scaled construction drawings will be required for major changes in and additions to materials or design for such items as roofs, moldings, porches, railings, fences, doors, windows, hardware, landscaping, lighting, etc.)

2. New Construction (including any new construction on the designated site)

Describe the nature of the proposed project in detail. *Cite specific Historic Standards which you feel are applicable. Attach additional sheets if needed.*

Include the following:

Plot plan with measured distances.

Scaled elevation drawings of each affected façade and specifications which clearly identify the appearance of the project.

Photographs of the proposed site.

Sketches, drawings, photographs, specifications, material cut sheets, color charts and/or samples of materials for such items as roofs, siding, doors, moldings, porches, railings, fences, doors, windows and hardware.

Landscaping plan including scaled drawing, plant specifications, etc.
